#### Introduction

The findings of a recent study showed that there is a significant benefit to students who participate in out-of-school-time (OST) programs. In fact, the Return on Investment of Summer school Programs in Pennsylvania study determined that for every dollar invested in summer school programming for students there was a return of \$6.69 in potential benefits to students, including reduced rates for dropouts, teen pregnancy, substance abuse, crime and delinquency (Link PSAYDN.org).

In accordance with the American Rescue Plan (ARP) Act and Pennsylvania Act 24 of 2021 (Act 24), the Pennsylvania Department of Education (PDE) will award approximately \$50,000,000 or one percent (1%) of Pennsylvania's ARP Elementary and Secondary School Education Relief (ESSER) State Reserve funds to support school districts, charter schools and cyber charter schools (collectively, LEAs) in the development and implementation of comprehensive after-school programs to address learning loss in response to the academic, social, emotional and mental health needs of students and subgroups of students impacted by COVID-19 public health emergency that supplement school programs and activities.

Act 24 requires that, when available, existing personnel shall be utilized by school districts, charter schools and cyber charter schools to staff programs and activities established with these grant funds.

Within 90 days of receipt of these allocations, school districts, charter schools and cyber charter schools must submit a three- part plan to PDE, that outlines the proposed use of the grant money, itemized by program and activity. This plan is part of a consolidated application that includes after-school programming, summer programming, and a comprehensive plan to address learning loss. The plan shall include:

- 1) A description of each program and activity
- 2) A narrative outlining the expected benefit of each program and activity
- 3) A budget for each program and activity detailing personnel and operating costs

#### **Indicators of Impact**

To determine the impact of the pandemic on students since March 2020, Ringgold School District considered student data points including state assessment results, course grades, and disciplinary referrals. At the high school, credits earned were also taken into consideration.

The district also reviewed common assessment data K-12 in language arts and mathematics for the 2021-2022 school year. State assessments scores from the Spring of 2021 indicate that more than fifty percent of economically disadvantaged students scored basic or below basic on their respective exams. Discipline referrals are significantly higher at this point in 2021 than they were at the same time in 2020, and more than ten percent of students at the high school failed a course in 2021, with ninth grade students having the highest percentage of course failures. Nearly fifty percent of students across the district qualify as economically disadvantaged, and every school building is a school-wide, Title I school. Since each building qualifies for school-wide, Title I funding, the district determined that all students in grades K-8 may voluntarily participate in summer programming. For grades 9-12, summer programming will focus on credit recovery. Students who qualify as economically disadvantaged will be specifically targeted for participation when individual student data demonstrates that a student will benefit from the applicable programming.

For credit recovery 9-12 and academic summer programming K-8, the resources are the teachers who will be providing academic support for students, and teachers will utilize the district curricular materials which are aligned to the Pennsylvania standards, as applicable. There is evidence that intensive tutoring improves academic performance, however, as participation in summer programming will be voluntary, students may not attend the requisite number of sessions to meet the threshold noted in such research. For emotional wellness, staff members will utilize social-emotional resources from a vendor to be determined, and any other pupil services will be provided by appropriately state certified staff.
